***Vendor Application & Agreement***

1. Vendor space shall be 10' x 10' under a tent in the parking lot at 19 Temple Street. Vendors will be provided with two (2) 8' banquet tables and two (2) folding chairs. Additional tables are available for rent for \$15 each.
2. Cost per vendor shall be \$300. Vendors shall pay in full by the application deadline, April 1, 2010.
3. Vendor operating hours shall be from 6:00pm to 11:00pm on Friday, June 11, 2010; 12:00pm to 11:00pm on Saturday, June 12, 2010; and from 11:00am to 6:00pm on Sunday, June 13, 2010. Times subject to change.
4. Vendor set-up time shall begin at 12:00pm on Friday, June 11, and at 8:00am on Saturday and Sunday, June 12 & 13, 2010. Vendors shall be set up and open for business by 6:00pm on June 11, by 12:00pm on June 12, and by 11:00am on June 13. All vendor vehicles used in the course of setting up must be removed from the parking lot and Festival area by 5:00pm on June 11, by 11:00am on June 12, and by 10:00am on June 13.
5. Vendors are allocated three (3) admission passes to the Festival per day. Each vendor is required to present a pass on each day of the Festival.
6. Vendors are responsible for cleaning and disposing of their own trash. Failure to do so will result in not being invited back the following year.
7. Vendors shall provide copies of sales tax license or tax id number, along with certificate of liability insurance naming Worcester Hibernian Cultural Foundation, Inc., Hibernian Cultural Centre, and Fiddlers' Green as additional insured.
8. While there will be overnight security during the Festival, the Vendor hereby acknowledges and assumes the risk of leaving any items, possessions, or belongings at the Festival overnight.
9. Vendor hereby agrees that the Worcester Hibernian Cultural Foundation, Inc., the Hibernian Cultural Centre, Fiddlers' Green, and any agents, representatives, organizers, or coordinators of the Worcester Irish Music Festival are not responsible for the loss, theft, injury, or damage to the vendor or the vendor's products, items, or goods. Vendor hereby further agrees to release, waive, and hold the Worcester Irish Cultural Foundation, Inc., the Hibernian Cultural Centre, Fiddlers' Green, and any agents, representatives, organizers, or coordinators of the Worcester Irish Music Festival, their agents, contractors, successors, and assigns harmless against any and all claims including without limitation third party claims for personal injury, product liability, theft, breakage, or other damage, from or otherwise pertaining to this agreement.
10. Vendor expressly assumes the risk of rain, wind, lightning and other weather-related elements on the days of the Worcester Irish Music Festival. The Worcester Hibernian Cultural Foundation, Inc., the Hibernian Cultural Centre, Fiddlers' Green, and any agents, representatives, organizers, or coordinators of the Worcester Irish Music Festival expressly disclaim any obligation or representation related to the number of persons attending the Festival, or the revenue to be generated.
